United Way, Allegheny County and partners celebrate VITA Awareness Day *Free tax preparation helps low-wage workers build financial stability, boosts local economy*

Pittsburgh, Pa. (*March 11, 2016*) – United Way of Southwestern PA, in partnership with the Money in Your Pocket Coalition (MIYPC), has joined with Allegheny County and other partner agencies to provide local eligible workers with free tax preparation services at IRS Volunteer Income Tax Assistance (VITA) sites. In order to raise more awareness in the community about the free tax prep sites, United Way, along with the County, will observe VITA Awareness Day on Tuesday, March 15.

"Each year, VITA programs help local working families, who might be struggling to make ends meet, access tax credits through free tax preparation," said Angela Reynolds, United Way's Director of PA 2-1-1 Southwest and Helping Families Thrive. "This is money that can help people meet basic needs, from an unexpected bill, to maintaining reliable transportation, to putting food on the table. We hope to raise more awareness about the IRS-certified volunteers engaged with free tax sites in our community, so we can help even more individuals and families in need."

United Way's Free Tax Prep Campaign has already filed more than 3,000 tax returns in Allegheny County this year, thanks to the help of over 225 IRS-certified VITA tax preparers. Last year, across the region, United Way tax preparers helped file more than 10,000 tax returns, resulting in millions of dollars in tax refunds for households in the region.

Allegheny County, which hosts a free tax site at its Department of Human Services, has filed more than 165 tax returns and has developed programming and outreach to serve immigrants and refugees, as well as restaurant and lodging employees.

"We are pleased to be part of such a huge push to help our local workers get more of their money back during the tax season," said County Executive Rich Fitzgerald. "Each year we hope to raise even more awareness of the sites and continue launching new, innovative programming to reach even more tax-payers in need."

VITA programs offer low-wage workers a free alternative to more-costly tax preparation services. The sites are IRS-sponsored and closely monitored by the agency.

Appointments for free tax preparation can be made by dialing 2-1-1, texting your zip code to 898-211, or visiting www.pa211sw.org, the free, 24-hour human services information and referral line powered by United Way. 2-1-1 resource navigators schedule free tax preparation appointments for VITA sites in four counties (Allegheny, Greene, Washington and Westmoreland) and make service referrals for Fayette and Lawrence counties, which are also part of the MIYPC. 2-1-1 serves as a resource for free tax preparation assistance for 11 counties throughout Southwestern PA. Households with a total annual income up to \$54,000 *may* qualify for free in-person tax preparation; free online tax assistance is available for individuals and families with a total annual income up to \$62,000.
